TERMS OF REFERENCE (TOR)**

1. SCOPE

1.1 Purpose

Bids are hereby invited for the **SUPPLY AND DELIVERY OF 1 X PETROL DRIVEN BREAKER (JACKHAMMER)**.

1.2 Background and description of project

Witzenberg Municipality includes the towns and rural areas of:

- Ceres,
- Prince Alfred's Hamlet,
- Op-die-Berg,
- Tulbagh, and
- Wolseley

Witzenberg Municipality is required to deliver services to the abovementioned areas. Electrical maintenance forms part of that responsibility and it's important to have the necessary equipment and materials.

1.3 Pre-qualification Requirements

1.3.1 Minimum score for functionality

In order to be considered for a contract in terms of this bid, bidders must achieve the minimum score for functionality as stated below:

The description of the functionality criteria and the maximum possible score for each is shown in the table below. The score achieved for functionality will be the sum of the scores achieved for the individual criteria.

Maximum possible score for functionality	40

The minimum score for functionality is **31** out of a maximum possible score of **40**. Bidders that fail to achieve the minimum score for functionality will **NOT** be eligible for evaluation and their bid will be rejected.

Bidders that score at least 31 for functionality and are also specifications compliant will be evaluated according the 80/20 principal.

A more detailed explanation of the functionality criteria is given below:

1.3.2 Similar successfully completed projects

Bidders must complete **Schedule: Previous Experience**, which is a list of the bidder's past work experience in terms of similar successfully completed projects. The value and scale of the projects indicated for these purposes must be supplied together with the other relevant information requested based upon which up to **10 points** for functionality will be awarded to the bidder under consideration in this regard.

Note: Where the entity bidding is a joint venture, a score for track record will be awarded to each party to the joint venture which will then be combined in proportion to the percentage contribution of each party to the joint venture.

1.3.3 Quality

The products supplied must meet the needs of the Municipality and other stakeholders. It must meet statutory and regulatory requirements related to the products.

Bidders must complete **Schedule: Quality**, which lists the compliance of products to minimum standards and the company’s quality management system based upon which up to **30 points** for functionality will be awarded to the bidder under consideration in this regard.

1.3.4 Functionality Evaluation Criteria

The scoring categories that will be used to evaluate the functionality submissions are shown below. Bidders are advised to carefully study these sheets to ensure that the correct information in this regard is provided in the relevant schedules of their bids.

These sheets only serve as an indication to the bidders on the methods and points criteria that will apply to the evaluation of functionality of their bids. The sheets will be completed by the Engineer based on the information supplied in the relevant schedules prior to bid evaluation.

1.3.4.1 Similar successfully completed projects (maximum 10 points)

RESPONSIVENESS CRITERIA

No bid will be considered by Witzenberg Municipality unless it meets the following responsiveness criteria (for the bid to be considered responsive, the bid **must** meet the following requirements):

- a) The bid must be properly received in a sealed envelope. The outside of the envelope must clearly indicate the bid title, the bid number, the name and address of the bidder and the closing date of the bid.
- b) The bid must be deposited in the relevant bid box as indicated on the notice of the bid on or before the closing date and time of the bid. **Telephonic, facsimile, electronic/ emailed and late bids will not be accepted.**
- c) An original Valid Tax Clearance Certificate must be attached to the bid document. **Bidders who are registered on the municipality's accredited supplier database and submitted an original and valid tax clearance certificate with their application form do not need to submit it again with this bid, provided that the original tax clearance certificate will be valid at the time of bid closing. - 2.5 **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 **“contract”** means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 **“EME”** means any enterprise with an annual total revenue of R5 million or less.
- 2.10 **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 **“non-firm prices”** means all prices other than “firm” prices;
- 2.13 **“person”** includes a juristic person;
