
1. SCOPE

1.1 Purpose

Bids are hereby invited for the **SUPPLY**, **DELIVERY AND INSTALLATION OF NEW STAGE CURTAINS**, **WITZENVILLE HALL TULBAGH.** Preparation works include the removal of existing rails, tracks and material. Installation must be complete with new curtain tracks and a new opening mechanism for main curtains.

The Scope comprises of the following:

- 1.1.1 Supply and Installation of Main Curtains (Front) complete with Heavy Weight Industrial open/close mechanism complete with pulley and cable system according to opening width, drop and curtain weight.
- 1.1.2 Supply and Installation of 6 fishbone Curtains (3 drops at each side); complete on curtain rail, attached to standard fixed system
- 1.1.3 Supply and Installation of 1 curtain (Back Wall) complete on curtain rail, attached to a standard fixed system
- 1.1.4 Supply and Installation of 3 x valances parallel with main curtains; complete on curtain rail, attached to standard fixed system.
