
### 1. SCOPE

### 1.1 Purpose

Bids are hereby invited for the SUPPLY, DELIVERY AND INSTALLATION OF NEW STAGE CURTAINS, CERES TOWN HALL.

- 1.1.1 Supply And Installation Of Main Curtains (2 Drops) (+- 10m X 3.70 M) And Attached To **Existing** Pulley And Open / Close Cable System To Form Uniform Operating System
- 1.1.2 Supply And Installation Of Curtains Above Staircases (2 X +- 3.15m X 5.35m) Complete On Curtain Rail, Attached To Standard Fixed System ( **See A On Sketch**)
- 1.1.3 Supply And Installation Of Curtains On Curtain Rail, Attached To Standard Fixed System (+/- 600mm X 3.6m) ( See B On Sketch)
