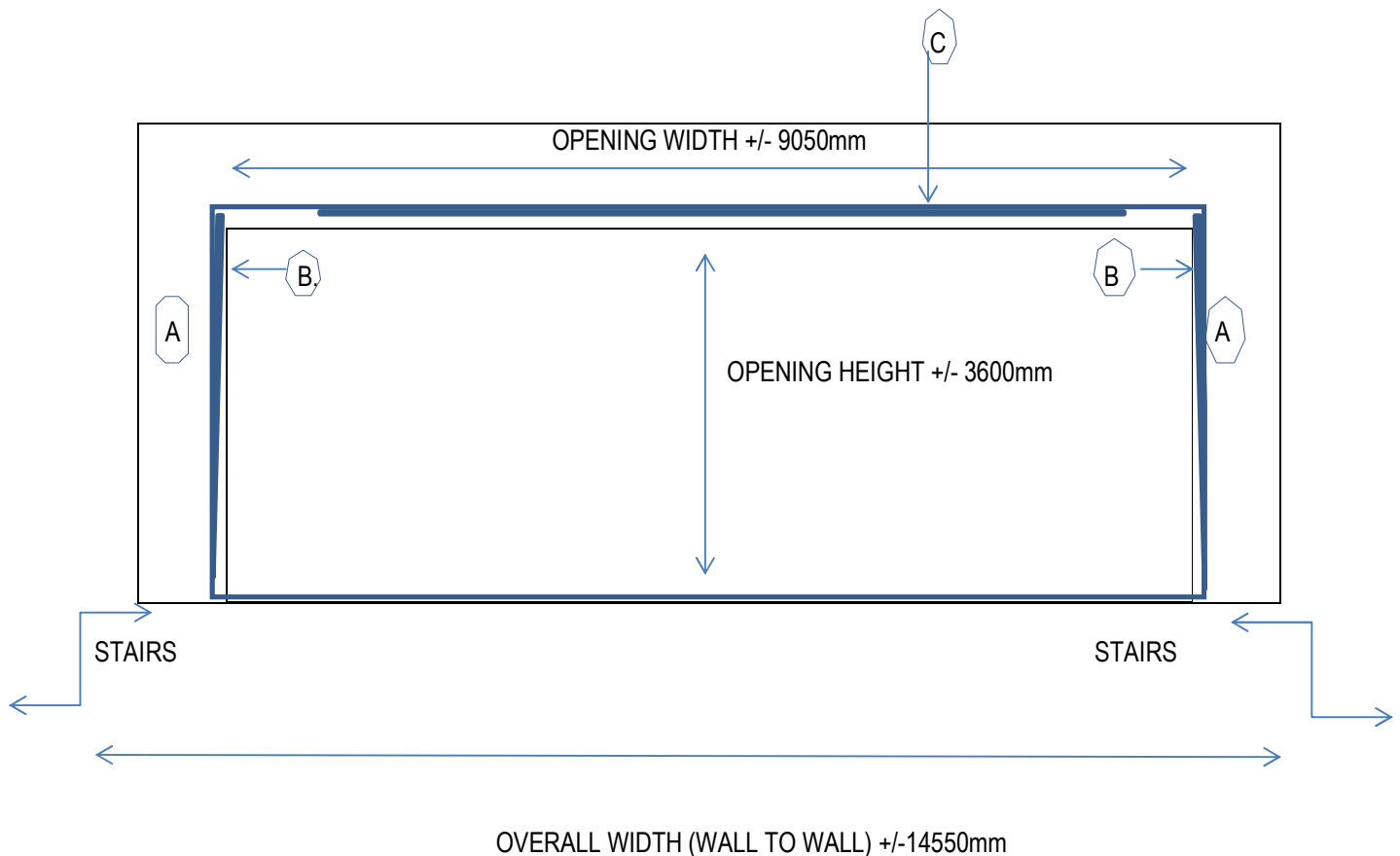
1. SCOPE

1.1 Purpose

Bids are hereby invited for the **SUPPLY, DELIVERY AND INSTALLATION OF NEW STAGE CURTAINS, CERES TOWN HALL.**

The Scope comprises of the following:

- 1.1.1 Supply And Installation Of Main Curtains (2 Drops) (+/- 10m X 3.70 M) And Attached To **Existing** Pulley And Open / Close Cable System To Form Uniform Operating System
- 1.1.2 Supply And Installation Of Curtains Above Staircases (2 X +/- 3.15m X 5.35m) Complete On Curtain Rail, Attached To Standard Fixed System (**See A On Sketch**)
- 1.1.3 Supply And Installation Of Curtains On Curtain Rail, Attached To Standard Fixed System (+/- 600mm X 3.6m) (**See B On Sketch**)

No bid will be considered by Witzenberg Municipality unless it meets the following responsiveness criteria (for the bid to be considered responsive, the bid **must** meet the following requirements):

- c) An original Valid Tax Clearance Certificate must be attached to the bid document. **Bidders who are registered on the municipality's accredited supplier database and submitted an original and valid tax clearance certificate with their application form do not need to submit it again with this bid, provided that the original tax clearance certificate will be valid at the time of bid closing.
