
#### 1. SCOPE

#### 1.1 Purpose

Bids are hereby invited for the Supply, Delivery And Installation Of New Stage Curtains, Bella Vista Community Hall.

The Scope comprises of the following:

- 1.1.1 Supply And Installation Of Main Curtains (2 Drops) ( +- 11.4m X 3.95 M) And Attached To Existing Pulley And Open / Close Cable System To Form Uniform Operating System
- 1.1.2 Supply And Installation Of 1 Valance Parallel With Main Curtains; Complete On Curtain Rail, Attached To Standard Fixed System (+- 11.4m X 0.45 M) (See C On Sketch)
- 1.1.3 Supply And Installation Of 6 Fishbone Curtains (3 Drops @ Each Side); Each Complete On Curtain Rail And Attached To Standard Fixed System (+-1.5m X 3.8m)
