1. SCOPE

1.1 Purpose

Bids are hereby invited for the Supply and Delivery of Weaponry Items for Traffic and Law Enforcement Officers.

1.2 Background and description of project

Witzenberg Municipality includes the towns and rural areas of:

- Ceres
- Prince Alfred's Hamlet,
- Op-die-Berg,

1.3 Pre-qualification Requirements

- 1.3.1 Bidder must have a minimum of 5 (five) years appropriate, verifiable experience in the firearm industry. Bidders are required to complete the schedule on page 4 of the bid document in order to prove their experience.
- 1.3.2 Bidder must have successfully completed at least 2 (two) similar projects to the supply of 9 mm handguns and associated related equipment. Bidders are required to complete the schedule on page 4 of the bid document in order to prove their previous experience of similar projects of similar sizes.
- 1.3.3 Bidder must be a Certified Armourer or Registered Official firearms Dealer in terms of the firearms control act issued by the **South African Police Services** (proof of certified armourer or registration as firearm dealer must be attached).

1.4 Special Conditions

- 1.4.1 Bidder is responsible for the safe storage during the licensing application period and the delivery / insurance during transportation, of said firearms to Witzenberg Municipal premises in Ceres.

- 1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

- 2.4 **"bid"** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 **"Broad-Based Black Economic Empowerment Act"** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 **"comparative price"** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 **"consortium or joint venture"** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 "contract" means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 **"EME"** means any enterprise with an annual total revenue of R5 million or less.
- 2.10 "Firm price" means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 "functionality" means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 "non-firm prices" means all prices other than "firm" prices;
- 2.13 "person" includes a juristic person;
- 2.14 **"rand value"** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 "sub-contract" means the primary contractor's assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 "total revenue" bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
