### 1. SCOPE

# 1.1 Bids are hereby invited for the APPOINTMENT OF A SERVICE PROVIDER FOR THE EDITING OF THE CURRENT DRAFT WITZENBERG LED STRATEGY.

#### 1.2 Background and description of project

Witzenberg Municipality includes the towns and rural areas of:

#### **1.3 Pre- Qualification Criteria**

- **1.3.1** Bidders must have successfully executed 1 similar project of a similar size during the past 5 years. Written proof of a LED (Local Economic Development) document that was drafted for a public entity must be attached.
- **1.3.2** Training background: The bidder to have under their employment relevant Degree(s) in Business, Economics, Social Sciences or other related applicable fields. **Proof must be attached.**
