1. SCOPE

1.1 Purpose

The purpose of the bid is to invite service providers to bid for the **Leasing of Office Space to Witzenberg Municipality, Ceres** from date of contract signing until 30 June 2020 in Voortrekker Street, Ceres.

1.2 Witzenberg Municipality includes the following towns and rural areas

Witzenberg Municipality is required to deliver services to the abovementioned areas.

1.3 Pre-Qualification Criteria
