TERMS OF REFERENCE (TOR)

1. SCOPE

1.1 Purpose

Bids are hereby invited from suitable service provider for the Removal of Existing Timber Floor and Casting of a New Concrete Floor Slab in 3 Classrooms at **Zanokhanye Creche, Station Road, Tulbagh**.

Scope of works:

- 1.1.1 Breaking down of existing timber floor of 3 classrooms and prepare to receive new concrete floor.
- 1.1.2 The size of 2 of the classrooms is +-32 square meters per classroom (thus 2 x 31.5 square meters). The 3rd classroom is +-18 square meters.
- 1.1.3 Construction of service bed and topping
- 1.1.4 Laying of Vinyl tiles on top
- 1.1.5 Tenderers should conduct a site inspection and take measurements of the flooring system of the 3 classrooms.
- 1.1.6 The measurements as indicated above are only estimated measurements, bidders must arrange appointment with the relevant staff of Zanokhanye crèche to take their own measurements.

1.2 Background and description of project

Witzenberg Municipality is required to deliver services to the abovementioned areas.

2 PRE-QUALIFICATIONS

- 2.1 Bidders should have a CIDB contractor grading of 1GB or higher.
- 2.2 Bidder must successfully completed 2 (two) similar projects of similar sizes. Bidders are required to complete the schedule on page 4 of the bid document in order to prove their previous and current experience of similar projects of similar size during the past 5 years.

3. SPECIAL CONDITIONS OF CONTRACT

- 3.1 Retention period is 2 months after completion of the works, with a 5% retention amount.
- 3.2 The practical completion period is 6 weeks.
- 3.3 The appointed Contractor must inform the building inspector as soon as the works have been completed in order to conduct completion inspection.
- 3.4 A fault list of any defects will be drafted by the building inspector and provided to the contractor in order to rectify mistakes.
- 3.5 After completion of any defects the final completion inspection period will follow (1 day), after which the works will be signed off.
- 3.6 Materials and workmanship shall be of good quality.
- 3.7 Only new and undamaged materials shall be used in the Works.
- 3.8 Work shall be to the approval of the Witzenberg Municipality and shall be executed in accordance with the relevant written recommendations and instructions where applicable.
- 3.9 All material, equipment and labour to be included in bid price.

1.1	Hacking up /off and removing of floor covering including removal of any adhesive from the timber floor boards.

1.3	The lip channels should not be taken out as it acts as a bracing component to the structure.
