### 1. SCOPE

1.1 The purpose of the bid is to invite service providers for the Supply And Delivery of a Once-off purchase of Lime Hydrated Premier White 9000kg (360x25kg bags <u>OR</u>450 x 20kg bags) and 210 drums Calcium Hypochlorite 25kg from date of Contract signing up until 30 June 2020.


