1. SCOPE

1.1 Purpose

The purpose of this bid is for the **APPOINTMENT OF A SERVICE PROVIDER FOR THE REBUILD / RECONDITION AND COMPLETE ASSEMBLE OF DIESEL ENGINE (RE-ADVERTISEMENT)**. Rebuilding of a Nissan UD90 – FE6T Turbo charged 6-cylinder engine, which must include the supply of a replacement cylinder block and crankshaft and all other related parts as listed in the bill of quantities. Diesel injection pump, injectors and turbo charger is also included in said repairs.

Engine is removed and stripped and can be perused / inspected at the Municipal Mechanical workshop at the C/O Dromedaris and van Riebeeck street Ceres.

1.2 Witzenberg Municipality includes the following towns and rural areas
