TERMS OF REFERENCE (TOR)

1. PURPOSE

- 1.1 The purpose of the bid is to invite service providers for the **APPOINTMENT OF A SERVICE PROVIDER FOR THE MONITORING, MAINTENANCE AND ARMED RESPONSE SERVICES FOR WITZENBERG MUNICIPALITY** from date of Contract signing up until 30 June 2021.

(a) **Cluster 1:**

Supply of a Monitoring and Maintenance System and Armed response Services by using the existing alarm system of the municipality which is installed 98% with a Paradox system and 2% with an IDS system at municipal buildings and sites in the Witzenberg municipal area of Ceres, Nduli, Bella Vista, Prince Alfred Hamlet and Op-die-Berg.

(b) **Cluster 2:**

Supply of a Monitoring and Maintenance System and Armed Response Services by using the existing system of the municipality which is installed 100% with a Paradox system at municipal buildings and sites in the Witzenberg Area of Wolseley and Tulbagh.

1.2 Background and description of project

Witzenberg Municipality includes the towns and rural areas of:

- Ceres,
- Prince Alfred's Hamlet,
- Op-die-Berg,
- Tulbagh, and
- Wolseley

1.3 PRE-QUALIFICATION CRITERIA

- 1.3.1 The bidder must be registered with the Private Security Industry Regulatory Authority (PSIRA). Certified proof of registration of the company must accompany the bid in order to comply with section 20(i)(a) and 20(2)(a and b) of the Private Security Regulations Act (Act 56 of 2001). Failure to submit proof with the bid documents at the closing of the bid may result in the bid not being evaluated and may be deemed non responsive. **Proof to be attached.**
- 1.3.2 The bidder must list their track record of at least 2 monitoring, maintenance and armed response services contracts successfully completed during the past 5 years to the amount of R 50 000-00 on combined value. Bidders must complete the table on the applicable page of this document indicating their previous or / and ongoing experience. **Proof to be attached.**

1.4. SPECIAL CONDITIONS OF THE CONTRACT

- 1.4.1 The service provider must at own cost replace and install its own radio transmitters.
- 1.4.2 The bidder must respond to site call out as follows:
- 1.4.2.1 On working days the supplier responded with a call to the dedicated employee at the site in reaction of an alarm signal and if no answer is received, the call out time starts immediately with the reaction officer moving to the site.

- 1.4.2.2 During the night time, weekends and holidays the call out time starts the moment the alarm signal is received by the supplier and the reaction officer must move to the site.
- 1.4.2.3 That if the bidder fails to perform in respect of the site call out, supra, the clients shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculation on the unperformed services using the current prime interest rate calculator for each day of the delay.
- 1.4.2.4 The response time to a site call out is as follows:
- (a) Ceres = 4 minutes
 - (b) Nduli = 7 minutes
 - (c) Bella Vista = 6 minutes
 - (d) Prince Alfred's Hamlet = 6 minutes
 - (e) Op-die-Berg = 20 minutes
 - (f) Wolseley = 6 minutes
 - (g) Tulbagh = 4 minutes
- 1.4.3 The bidders provide reaction vehicles on standby in the following zones 24/7
- Ceres – 3
Tulbagh – 1
Wolseley – 1
Bella Vista and Prince Alfred's Hamlet – 1
- 1.4.4 Bidders must have control room which is manned 24/7 365 days a year from which monitoring will take place.
- 1.4.5 That for the duration of the contract the control room must be situated within the Witzenberg municipal area. The control room must be established within 30 days from date of signing contract.
- 1.4.6 Armed response officers must be dressed in full company security uniform when on duty.
- 1.4.7 Bidders must submit a monthly report in respect of call outs, maintenance and damages and losses or any other relevant information.
