1. SCOPE

1.1 Purpose

The purpose of this bid is for the **APPOINTMENT OF A SERVICE PROVIDER FOR THE REBUILD / RECONDITION INCLUDING THE COMPLETE ASSEMBLE OF TWO DIESEL ENGINES (Toyota WO4D & Mitsubishi 4D32)**. Rebuilding and complete assemble, of two light truck engines which must include and all other related parts and repairs as listed in the bill of quantities. Diesel fuel injection pump and injectors also included.

1.2 Witzenberg Municipality includes the following towns and rural areas
