### 1. SCOPE

#### 1.1 Purpose

The purpose of this bid is for the supply, deliver and fit two new vacuum pumps for the two trucks as listed hereunder:

- **CT18168 (Toyota DA110)**
- **CT 16357 TATA LPT1518**

Pumps to be supplied and fitted must be similar in built, type and quality as the *JUROP PN33D* vane type pump currently in use on our vacuum trucks.

Reason for the above being that fitting of a pump with similar build characteristics and size will greatly cut the cost of changing current mounting brackets and piping etc.

Bidder also to provide elementary training to operator regarding the daily operation and care of the pump to be supplied and fitted.
