TERMS OF REFERENCE (TOR)

1. SCOPE

1.1 Purpose

The purpose of this bid is to invite service providers to bid for the **Supply and Servicing of Portable Chemical Toilets and Emptying of Septic Tanks in The Witzenberg Area** for a period of 3 months from date of contract signing.

1.2 Witzenberg Municipality includes the following towns and rural areas

- Ceres;
- Prince Alfred's Hamlet;
- Op-die-berg;
- Tulbagh; and
- Wolseley

Witzenberg Municipality is required to deliver services to the abovementioned areas.

1.3 Pre-Qualifications

1.3.1 Bidder must have successfully completed at least 1 (one) similar project of similar size. Bidders are required to complete the schedule on page 4 of the bid document in order to prove their previous experience of similar projects. **Proof must be attached to this bid document.**

1.3.2 Bidder must have their own truck with a vacuum tank with the capacity of at least 6000 litres. (Proof must be attached to this bid document)

1.4 Special Conditions of Contract

1.4.1 The successful bidder must be able to react and be on-site within 24 hours from notification by the relevant municipal official.

1.4.2 In order to be considered for an appointment in terms of this bid, it will be beneficial to the bidders to have an office in the Western Cape Province, through which all communication with the employer will flow, and where the majority of work in terms of this bid will be carried out.

1.4.3 Successful bidder must submit an incident management plan within 14 days after appointment.

1.4.4 Kilometres travelled will be measured from Municipal Depot, Dromedaris Street, Ceres.

1.4.5 Toilets must be serviced at least twice a week.
