TERMS OF REFERENCE (TOR)

1. SCOPE

1.1 Purpose

Bids are hereby invited from suitable and experienced service providers for the **UPGRADING OF VEHICLE TESTING EQUIPMENT (RE-ADVERTISEMENT)**.

Witzenberg Municipality calls for the submission of bids for the supply, deliver, installation and commissioning of specialized vehicle test station equipment for an A-grade vehicle testing station.

Upgrade of existing A-grade roller brake tester (Clifford) according to legislation, SANS 10216: 2017 Edition 6

Must be a remote control system with virtual remote back up.

Database back up of all entered examination data (upgraded to include visual image of vehicle tested).

Upgraded to be accessed via 3G modem to enable remote fault finding and software updates.

An integrated camera able to automatically take images of the vehicle at the inspection pit, in front of the brake roller tester.

1.4.2 Software updates as and when available during annual service and calibration of equipment.

1.4.5 All equipment must meet the requirements of SANS approval.

1.4.6 Training on how to operate all upgraded equipment must be provided to Staff members involved in the testing of vehicles for roadworthy.

1.4.8 Removal of existing equipment must be included in the bid price (existing equipment to remain the property of Witzenberg Municipality).

1.4.9 The delivery and the installation of the equipment must be completed within 30 working days after signing of the contract.

 - (a) has been requested to submit a bid in response to this bid invitation;
