#### 1. SCOPE

#### 1.1 Purpose

The purpose of this bid is to invite service providers for the **PAINTING OF EXTERNAL SURFACES AT KLIPRUG COMMUNITY HALL PRINCE ALFRED HAMLET**.

#### 1.2 Background and description of project:

Witzenberg Municipality includes the following towns and rural areas

#### 1.3 PRE-QUALIFICATION CRITERIA

1.3.1 Bidder or Individuals in their employment must have completed 3 projects in the painting of buildings to the value of minimum R25 000 each during the last 5 years. Bidders are required to complete the schedule on Page 4 in order to prove their previous experience of a similar project of similar size during the past 5 years. Failure to complete the schedule will be seen as submitting a non-responsive bid.
