TERMS OF REFERENCE (TOR)

1. SCOPE

1.1 Purpose

The purpose of this bid is for the **SUPPLY AND DELIVERY OF LPG (LIQUEFIED PETROLEUM GAS) AND WELDING GASES, EXCHANGE / REFILL THE OF GAS CYLINDERS** from date of contract signing until 30 June 2025.

1.2 Background and description of the project:

Witzenberg Municipality includes the following towns and rural areas

- Ceres;
- Prince Alfred's Hamlet;
- Op-die-berg;
- Tulbagh; and
- Wolseley

Witzenberg Municipality is required to deliver services to the abovementioned areas.

1.3 Pre-Qualification

1.3.1 The bidder must provide proof of a supplier agency agreement with a gas manufacturer, distributor or wholesaler.

1.4 Special Conditions of Contract

1.4.1 On-demand exchange or refill, collection, and delivery of gas cylinders. (1 day following receipt of an official purchase order)

1.4.2 Safety of cylinders and condition in compliance with relevant legislation.

1.4.3 Since the **Maximum Retail Price** of LPG is regulated in terms of the Petroleum Products Act only government-regulated price increases will be allowed, such a request must be lodged in writing and submitted with proof of the increase allowed in government regulations.

1.4.4 Prices to remain valid until 30 June 2025. However, the municipality may permit government-regulated price increases under the Petroleum Products Act, as the maximum retail price for LPG is regulated. Such a request must be submitted in writing and include sufficient evidence of the price increase permitted under government regulations.

1.4.5 Note that the needed products are regarded by law as dangerous goods, and Chapter VIII of the **National Road Traffic Act of 1996** and Chapter VIII of the **National Road Traffic Regulations of 2000** regulate the transportation of dangerous goods."

The vehicle used for transportation by the successful bidder must be in adherence to the National Road Traffic Act's provisions.
