1. SCOPE

1.1 Purpose

Bids are hereby invited for the **Supply, Delivery and Installation of Laminated Wood Flooring for Chalets at Pine Forest Holiday Resort**. The following to be supplied, delivered and installed to 31 G Chalets, 2 rooms per chalet with total of 62 rooms.

- a) Supply, deliver and fit new Walnut Laminated Wood Flooring in each chalet's rooms
 - 31 rooms = 2.6m² x 2.6m²
 - 31 rooms = 2.1m² x 3.1m²
- b) Supply, deliver and fit steel door strips in each chalet's rooms
 - 62 rooms = L 760mm x W 30mm
- c) Supply, deliver and fit treated Pine skirting in each chalet's rooms
 - 31 rooms = 2.6m² x 2.6m²
 - 31 rooms = 2.1m² x 3.1m²

No bid will be considered by Witzenberg Municipality unless it meets the following responsiveness criteria (for the bid to be considered responsive, the bid **must** meet the following requirements):

- c) An original Valid Tax Clearance Certificate must be attached to the bid document. - 2.9 "EME" means any enterprise with an annual total revenue of R5 million or less .
- 2.10 **"Firm price"** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 **"functionality"** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 **"non-firm prices"** means all prices other than "firm" prices;
- 2.13 **"person**" includes a juristic person;
- 2.14 **"rand value"** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
