Councillor K Yisa addressed the Speaker with regard to the notice of the Council meeting not being in compliance with item 6(9) of the Rules of Order for the meetings of the Witzenberg Municipality as published in the Provincial Government Gazette (2018). The Speaker further noted that the Rules of Order also states that late notice of a meeting does not render the meeting invalid as stated in item 6(10) of the Rules of Order.

Councillor A Gili challenged the Speaker indicating that due to the Speaker not following the Rules of Order for meetings, the ANC will be leaving the meeting and reporting the matter to the MEC.

Councillor J Cloete requested a five minute caucus break at 10:21.

The Council meeting resumed after the caucus break where after Councillor Cloete, on behalf of the Patriotic Alliance and in support of the ANC, indicated that the coalition will not be part of the meeting.

The ANC coalition left the meeting at 10:33.

The Speaker adjourned the meeting for a caucus break and resumed at 10:53 after which the Speaker informed the meeting that in terms of the Rules of Order there was a lack of quorum and that the meeting could not proceed.
