1. OPENING AND WELCOME

The Speaker welcomed everyone present and requested Councillor J Cloete to open the meeting with prayer.

NOTED

The Speaker ruled that the order of the agenda will be adapted to deal with important matters.

Councillor K Yisa stated that items cannot be dealt with until the Application for leave of absence has been communicated.

The Speaker responded that in terms of the Rules of Order the Speaker has prerogative to move items.

2. LEAVE OF ABSENCE AND CONFIDENTIALITY AND CONFLICT OF INTEREST DECLARATION

3. RESERVED POWERS

3.1 New Preferential Procurement Policy and proposed amendments to Supply Chain Management Policy (8/1/P)

The following documents are attached:

- (a) Memorandum from Director: Finance, dated 30 January 2023: **Annexure 3.1(a)**.
- (b) Draft Preferential Procurement Policy: **Annexure 3.1(b)**.
- (c) Supply Chain Management Policy: **Annexure 3.1(c)**.

Proposed changes:

- (a) That the Preferential Procurement Policy be approved. The policy allows for preference to local suppliers.
- (b) That the following provisions be deleted from the Supply Chain Management Policy:
 - (i) Remove the definition of Designated sector was applicable to local content.
 - (ii) Amend paragraph 14(3) to allow for quotations from suppliers listed on the Central Supplier database (Database of National Treasury).
 - (iii) Remove the reference to local content from paragraph 27(1)(e).
 - (iv) Remove the requirement that the decisions of the bid adjudication committee must be sent via registered mail from paragraph 37(10).
 - (v) Remove paragraph 41(2) to (8) as it is applicable to local content.
 - (vi) Remove paragraph 68 Preferential Procurement as it is replaced with the Preferential Procurement Policy.
 - (vii) Include a paragraph dealing with the cancellation of tenders.

At the Executive Mayoral Committee meeting Alderman BC Klaasen recommended the following amendments to the preference point system:

(3) Regarding paragraph 5(2) of this Policy, 25 % of the 20 points on the 80/20 preference points system and 25 % of the 10 points on the 90/10 preference points system, will be allocated to promote B-BBEE in terms of the following scorecard:

The Executive Mayoral Committee resolved on 27 February 2023 to recommend to Council that the Preferential Procurement Policy and the proposed amendments to the Supply Chain Management Policy be approved, with application from 16 January 2023.

The Municipal Manager informed the meeting that the changes to the Preferential Procurement Policy and the proposed amendments to the Supply Chain Management Policy are due to legislative amendments, therefore the policy must be adjusted in order to proceed with Supply Chain matters.

It is further noted that if tenders are awarded in terms of the old policy, it will amount to irregularities.

Councillor A Gili proposed that the matter regarding the New Preferential Procurement Policy and proposed amendments to the Supply Chain Management Policy be held in abeyance. The proposal was seconded by Councillor J Mouton.

Councillor P Daniels proposed that the item not be held in abeyance, but rather be amended and finalised. The proposal was seconded by the Executive Mayor.

The Speaker called for a vote on the proposals and the outcomes were as follows:

The Speaker ruled in favour of the majority votes casted that the item should not be held in abeyance, but be amended and finalised.

Councillor P Daniels proposed that the 80/20 preferential point system be amended to 10 points for BBBEE and 10 points for enterprises within the Witzenberg municipal area.

Additional amendments must be made to the 90/10 preferential point system resulting in BBBEE being 5 points and 5 points for enterprises within the Witzenberg municipal rea.

Furthermore that the amendments be implemented with effect from 10 March 2023. The proposal was seconded by Alderman K Adams.

Councillor A Gili counter proposed that the 80/20 preferential point system be amended to 15 points for BBBEE and 5 points for enterprises within the Witzenberg municipal area. Furthermore that the 90/10 preferential point system be amended to 7,5 points for BBBEE and 2,5 points for enterprises within the Witzenberg municipal area.

The Speaker called for a vote on the proposals and the outcomes were as follows:
