#### 1. SCOPE

#### 1.1 Purpose

The purpose of this bid is for the **PROVISION OF SECURITY SERVICES (1 MONTH APPOINTMENT)** at various municipal sites.

- **1.2** Witzenberg Municipality includes the following towns and rural areas

Witzenberg Municipality is required to deliver services to the abovementioned areas.

#### 1.3 Pre-Qualification Criteria

- 1.3.1 Service Providers must be registered with the Private Security Industry Regulatory Authority (PSIRA). Proof of registration of the company must accompany the bid document to comply with Sections 20(1)(a) and 20(2) (a and b) of the Private Security Industry Regulations Act (Act 56 of 2001). 
