## 1. SCOPE

## 1.1 Purpose

## The purpose of this bid is to invite service providers for the APPOINTMENT OF A SERVICE PROVIDER TO APPLY ADVANCED DRIVING SKILLS: DEFENSIVE DRIVING & SKIDPAN CAR CONTROL COURSE (RE-ADVERTISEMENT).

A programme to be done as in-house/ Provider premises on the days and time as agreed with the preferred provider for Apply advanced driving skills: DEFENSIVE DRIVING & SKIDPAN CAR CONTROL COURSE (RE-ADVERTISEMENT). Training to take place in groups (5-8 delegates per group) 30 delegates
