08/2/20/51: APPOINTMENT OF A CHAIRPERSON WITH THE RELEVANT LEGAL QUALIFICATION AND EXPERIENCE IN LABOUR LAW

To act on behalf of the Municipality against persons who is in contravention of the National Building Regulations.

The following matters needs to be attended to:

- a) Illegal building works, which resulted in the subdivision of the main house into different units.
- b) Dilapidated structure with illegal occupants.
- c) Construction which has been delayed for 6 years and which causes storm water problems for neighbours. The wall on side boundary is unsightly.
- d) Unfinished building works for more than 10 years which is causing problems for the neighbours.
- e) Dilapidated private owned buildings which area a risk for the community
- f) Illegal building works over the boundaries and has built a second residential unit without permission/plans.
