1. SCOPE

1.1 Purpose

The purpose of this bid is for the **HIRING OF 17 TON EXCAVATOR**

1.2 Witzenberg Municipality includes the following towns and rural areas

- Ceres;
- Prince Alfred's Hamlet;

Witzenberg Municipality is required to deliver services to the abovementioned areas.

1.3 Pre-Qualifications

1.3.1 The bidder must list their track record of at least 2 contracts for the supply and delivery of similar equipment / plant for which the bidder is appointed currently or which have been completed successfully during the past 5 years. **Proof to be submitted in form of contactable references.**

1.4 Special Conditions of Contract
