**1. Purpose**

1.1 Bids are hereby invited for the lease of the café building at PA Hamlet swimming pools. The period of lease is from the date of contract signing until 30 April 2023.

**2. Special conditions of contract**

- 2.1 It is required from the successful bidder to sign a lease agreement. In the event that the successful bidder does not sign the lease agreement, the award will be cancelled. The municipality reserves the right to stipulate the conditions of the lease agreement with the exception of the bid price as tendered.
- 2.2 The selling of liquor is prohibited. Delivery of milk, bread and groceries through local suppliers do not fall under the above.
- 2.3 It is required from the successful bidder to start operating the café from date of contract signing. Prospective bidders can visit the café before the closing time of the bid. The Acting Manager: Resorts and Swimming Pools may be contacted on 023 316- 8163 to arrange an appointment for viewing purposes only.
- 2.4 It is required from the successful bidder to buy their own electricity as the café building has a prepaid meter (3 phase electricity).
- 2.5 The following time schedule must be adhered to for the café at PA Hamlet Swimming Pool:
- 2.5.1 Ordinary Weekends  
Monday to Fridays: 13:00 till 18:00  
Saturdays: 10:00 till 18:00  
Sundays: 10:00 till 18:00
- 2.5.2 December/ January school holidays and in-season long weekends  
Daily: 10:00 till 18:00
- 2.6 The café at the PA Hamlet Swimming Pool must be open at least one hour in the morning and one hour in the afternoon for times not specified above.
- 2.7 The specified times as stated above must be on display on a notice board at the café. It must be noticeable and done by the lessee at his/ her own cost. The time schedule may be amended only in the event of an emergency and with the prior written permission from the Manager Resorts and Swimming Pools.
- 2.8 Provision must be made for service at certain functions or unscheduled busy periods at cafés at the resort.
- 2.9 The monthly lease amount must be paid up-front by the lessee, no later than the first working day of each month. Proof of payment must be forwarded to the Acting Manager Resorts and Swimming Pools.
- 2.10 Admission condition: Family and friends of the lessee are not allowed free entrance to the resort or any facilities inside the resort.
