### 1. SCOPE

#### 1.1 Purpose

The purpose of this bid is for the **SUPPLY AND DELIVER OF TWO CHLORINE GAS TRANSPORT TRAILERS** for Witzenberg Municipality.

#### 1.3 Pre-Qualification Criteria
