### 1. SCOPE

#### 1.1 Purpose

The Witzenberg Municipality is in need of the following services: **PAINTING OF BELLA VISTA COMMUNITY HALL AND ABLUTION FACILITY AT BELLA VISTA SPORTSFIELD**

#### 1.2 Witzenberg Municipality includes the following towns and rural areas

- Ceres;
- Prince Alfred's Hamlet;
- Op-die-berg;
- Tulbagh; and
- Wolseley

#### 1.3 PRE-QUALIFICATION

1.3.1 Bidder or individuals in its employment must have completed 3 projects in the painting of buildings to the value of minimum R25 000 each during the last 5 years. Bidders are required to complete the schedule on Page 4 in order to prove their previous experience of a similar project of similar size during the past 5 years. **Failure to complete the schedule will be seen as submitting a non-responsive bid.**

#### 1.4 SPECIAL CONDITION OF CONTRACT

1.4.1 The bid consists out of two clusters and the bid will be awarded per cluster and not as a whole.

1.4.2 All paint (primer and top coat), NS4, NS8, water sealant, super laykold tape and linseed oil to be supplied by the municipality.

1.4.3 Bidder to supply all other material and equipment related to the successful completion of the works.

1.4.4 Progress inspections will be conducted by the Project Manager or her nominee:

- Before prime coats are applied
- Before final coats are applied, and must be timeously arrange
- Final inspection after final top coat

No bid will be considered by Witzenberg Municipality unless it meets the following responsiveness criteria (for the bid to be considered responsive, the bid **must** meet the following requirements):

- a) The bid must be properly received in a sealed envelope. The outside of the envelope must clearly indicate the bid title, the bid number, the name and address of the bidder and the closing date of the bid.
- b) The bid must be deposited in the relevant bid box as indicated on the notice of the bid on or before the closing date and time of the bid. **Telephonic, facsimile, electronic/ emailed and late bids will not be accepted.**
- c) **Bidders must provide a valid Tax Verification Details (Tax reference number and valid third party verification pin) as issued by SARS in order to confirm their tax compliance status. Failure to provide such details may result in your bid being disqualified.**
- d) An original or copy of the bidder's Broad-Based Black Economic Empowerment (B-BBEE) certificate must be attached to this bid document in order to claim B-BBEE points.
