1. SCOPE

1.1 Purpose

1.1.1. The purpose of this bid is to invite qualified and experienced service providers to submit a bid for **SUPPLY AND DELIVERY OF PORTABLE IRRIGATION SPRINKLERS.**

1.2 Witzenberg Municipality includes the following towns and rural areas

- Ceres;

Witzenberg Municipality is required to deliver services to the abovementioned areas.

1.3. Pre – Qualifications

1.3.1. Bidders must have successfully completed a minimum of two (2) similar projects in the supply of portable irrigation sprinklers with a minimum combined value of **R 100 000.00**.
